We will continue to increase membership, raise funds with garage sales and grant applications, rent out the greens to interested community or family groups, and continue with various social and games events as our main revenue source. Our main expenses continue in utilities, greens and equipment maintenance, bowls B.C. fees, and insurance. Rob Brown moved to accept this budget. Merlin Bunt seconded the motion. Vote taken and passed.

Facilities and Grant reports: The clubhouse gutters require replacing and \$3000 has been internally set aside for this. A grant submission was made to the B.C. Gaming Commission for greens outdoor lighting and the purchase of bowls. We will know the outcome of this in October. Given by Carol Jean Chevalier.

Greenskeeper report: given by Brian Elliott.

New Business: The Board of Directors will be holding another meeting with the city regarding club assistance on October 21st, 2024.
