Treasurer Report:

Bank Balance as of the 30th of April 2022 is \$4500. There are twenty-one full-time members as of today. (These dues are not reflected in the bank balance of the 30th of April).

Year to date-fiscal eight months ended the 30th of April 2022, we are on track with meeting and exceeding our Revenue projections, however we are overbudget with Expenses. It was necessary to purchase a new gas mower and string clipper and maintenance costs of existing equipment was higher than budgeted. Clubhouse insurance was \$500 more than budget. Website 2 yrs. renewal and advertising costs are higher than budget, and we had the large replumbing cost to repair the pipes to the street not in the budget.

Correspondence: The CLBC received from Brenda Golden a review of the history behind the Fire Door in the Locker Room. As we keep gas powered equipment in the Equipment room, and we have a furnace in the Locker room, there is risk of a fire occurring due to gas fumes. Following a Fire Inspection review, approx. \$10,000 was spent on a reno to the Equipment room in 2017 to bring this part of the building up to fire code safety standards at this time. **THIS DOOR MUST BE KEPT CLOSED AT ALL TIMES** to protect the rest of the building. We will purchase signage to this effect for mounting on both sides of the door. Till this is completed please remember to close the door. She also noted that all members should have access to the CLBSociety Bylaws. Bylaws are posted on the website in the Members Section under Meeting Minutes. We have also pinned a copy to the small bulletin board in the Locker room.
